

GUIDE TO PAYMENTS FOR COMMERCIALS MADE FOR USE OUTSIDE THE UK (TV AND INTERNET)

Prepared by the Personal Managers' Association and the Association of Model Agents, the guide shown on the right consists of suggested minimum rates for the rights to use one commercial on television only for a period of one year in the territory specified.

The use fee is shown as a percentage of the negotiated basic studio fee, and includes the right to use on terrestrial and cable television in the country concerned. Satellite use is also included where the station's primary audience is in the country purchased.

Where a satellite station audience is spread over a number of territories then an appropriate fee should be negotiated taking into account the availability of the product in those territories and the effect the exposure will have on the artist's ability to appear in other commercials in those territories.

Use on mobile devices (telephones etc) should be negotiated separately.

Each country is shown with its actual/estimated population. In the case of most of Europe, the number of homes where T.V. is viewed is almost 100%. Although this is not necessarily the case in other parts of the world, no individual territory is shown at a rate of less than 100% of the basic studio fee.

Percentages are based on a number of different factors including T.V. set counts, latest available population figures and economic strengths. Sources include ZenithOptimedia, The CIA's World Factbook and Whitaker's Almanack.

There are many territories shown (e.g. Liechtenstein) where no separate T.V. service is currently available. Figures are quoted in case such a service becomes available in the future.

As no territory is shown at less than 100%, it would not necessarily be appropriate to add together all the percentages if wanting to buy an entire continent. A suitable fee should be negotiated using the population figures for the whole region for guidance.

INTERNET (Website & Viral use)

Although the Internet is available on a world-wide basis, most websites are designed for individual national markets. Multi-language websites designed for international audiences should be negotiated, depending on the territories targeted.

Until the market for virals has been established, a suggested minimum one-off fee of 100% of the BSF is recommended provided the Viral is released at the same time as the TVC.

The suggested rates for a website in the language/s of the intended national market only for a period of up to one year are as follows (expressed as a percentage of the basic studio fee):-
